- Please do not wrap donations or make “goodie bags.” Because every patient’s condition is unique, we will be forced to unwrap/unpack donations to ensure appropriateness.
- In accordance with Infection Control policies and Children’s of Mississippi guidelines, there are a few things **we cannot accept**:
  - USED items (even gently used)
  - Religious items, or items that include religious references
  - Stuffed animals
  - Toy weapons or violent video games/movies
  - Candy
  - Latex balloons
  - Food and gas gift cards over \$15
  - iTunes gift cards
