MCCTR Provides Infrastructure for COVID-19 Study

MCCTR is housing one of 11 "CEAL" grants issued by the National Heart, Lung and Blood Institute. CEAL is an acronym for Community Engagement Alliance Against COVID-19 Disparities.

The objectives are to (1) conduct urgent community-engaged research and outreach focused on COVID-19 awareness and education to address the widespread misinformation about COVID-19 and promote an evidence-based response to the disease, and (2) promote and facilitate inclusion of diverse racial and ethnic populations in clinical trials, reflective of the populations disproportionately affected by the pandemic.

Caroline Compretta, PhD, a co-leader of MCCTR's Community Engaged Research Core,

and Michael Hall, MD, MS, MCCTR's Director of Clinical and Population Studies, serve as two of the study's three principal investigators. Victor Sutton, PhD, Director of the Mississippi State Department of Health's Office of Preventive Health and Health Equity, serves as the third principal investigator.

Joey Granger, PhD, serves as the CEAL Study's Director of Research Resources.

Several MCCTR faculty are participating as coinvestigators for CEAL study initiatives. Susan Mayfield-Johnson, PhD, a member of MCCTR's Investigator Development Program, Wendy White, PhD, a co-leader of the Community Engaged Research Core, are both directing distinct CEAL initiatives.

MCCTR Participates in National COVID Cohort Collaborative

Under the leadership of William Hillegass, MD, PhD, and in collaboration with UMMC's Center for Informatics and received a grant to support Analytics, MCCTR collaborative participation with seven other CTRs in the National COVID Cohort Collaborative (N3C). The N3C Registry contains data on more than 2.6 million tested and 370,000 COVID-19 positive individuals, extracted from the electronic health records of 73 healthcare institutions.

Funded by NIH's National Center for Advancing Translational Sciences (NCATS), N3C is the premier platform for observational COVID electronic health record-based research.

According to Hillegrass, "The assembled Data Enclave will be broadly available to investigators, both locally and throughout the nation. MCCTR's BERD Core will facilitate access and analysis of data for all MCCTR partner investigators."

Several options exist for investigators wanting to pursue research that utilizes the N3C, including investigatorinitiated project and participation in either a CTR Consortium project or an N3C working group.

Beyond COVID, NCAT views N3C as establishing the paradigm and infrastructure for the future of collaborative, efficient, and well-powered national electronic health record registries and research. The platform will include extensive use of machine learning. Further, N3C is developing and testing the concept of synthetic datasets. If successful, the synthetic data methods will provide a new state-of-the-art approach to efficiently perform electronic health record-based research while alleviating many privacy and data security concerns.

UMMC Hosting Several COVID-19 Clinical Trials

UMMC has a robust clinical research effort focused on evaluating multiple treatments for patients with COVID-19.

"To date," said Gailen Marshall, MD, PhD, Medical Director of UMMC's Clinical Research and Trials Unit and a member of the MCCTR Internal Advisory Committee, "We are engaged in 23 distinct clinical trials that have enrolled 712 patients as of December 20."

These trials include several treatments directed against the virus itself and other treatments aimed at the inflammation, sometimes called a cytokine storm, often responsible for serious illness and sometimes death.

UMMC is also involved in developing vaccines to prevent infection. The studies involve research participants throughout Mississippi, with a special emphasis on the state's diverse population.

These clinical trials have a variety of sponsors, including pharmaceutical companies, philanthropic organizations, and the Federal government. Said Marshall, "Our team is committed to doing all we can to help in bringing this devastating pandemic to an end for the benefit of all our state citizens."

Purpose: To enable potential applicants sufficient time to develop competitive applications that propose to test the effectiveness of an implementation-ready intervention designed to determine if a cardiovascular health (CVH) promotion module delivered within the context of a home visiting program can enhance maternal and early childhood CVH and address CVH disparities in mothers and children (0-5 years). The study population includes those who are of low socioeconomic status, or live in low resource or underserved rural or urban communities, or in diverse geographic regions of the U.S. with a high burden of cardiovascular disease risk factors. An FOA for clinical trials (UG3/UH3) will run in parallel with a companion FOA for an ENRICH Research Coordinating Center (U24).
