Project Details

1. Describe the commodity that the agency is seeking to procure:

The University of Mississippi Medical Center (UMMC) is seeking to expand current inventory of self-administration equipment. This purchase is for a set of in vivo test chambers to be used for drug self-administration studies in rats. These test chambers enable rats to press levers to self-administer their own intravenous injections of drugs, including common opioids like oxycodone and hydrocodone. These drugs are rewarding and therefore maintain high rates of lever-pressing behavior. The way we study "abuse deterrence" here is by testing novel compounds for their ability to reduce or eliminate the rewarding effects of opioids. "Deterrence" is operationalized by a reduction in drug-taking behavior relative to the levels of self-administration of the opioid prior to treatment. When a rat presses a lever, a signal is sent to an interface and then to a computer to process the information. The computer then signals a drug pump to infuse X ml of solution into the rat's catheter. This operation requires sophisticated hardware and software to ensure accurate and timely delivery of precise amounts of drug solution contingent upon the rat's behavior.

2. Explain why the commodity is the only one (1) that can meet the needs of the agency:

UMMC Department of Research is facilitating ongoing behavioral research surrounding non-human primates using the MedAssociates equipment. The department is seeking to expand current inventory to support a new research study described above. Additional selfadministration equipment that is compatible with the current MedAssociates equipment is needed for this project.

3. Explain why the source is the only person or entity that can provide the required commodity:

MedAssociates Incorporated is the sole manufacturer and supplier of the In Vivo test chambers that are compatible to integrate with existing equipment. They are not available from any other distributor. See supporting letter from MedAssociates Incorporated, Attachment A.

- 4. Explain why the amount to be expended for the commodity is reasonable: The estimated amount to be expended is for the purchase of the In Vivo test chambers is \$52,600.00. This amount is within the expected price range for these products.
- 5. Describe the efforts that the agency went through to obtain the best possible price for the commodity:

Through market intelligence, UMMC was able to negotiate best pricing for these products. All applicable discounts were explored and applied.
